



ProVia Aluminum Storm Door Tax Credit Certification

This manufacturer's certification statement provides the documentation needed to receive an energy tax credit for ProVia Aluminum Storm Doors as defined by the *American Recovery and Reinvestment Act of 2009*. How to Qualify for the 2009 - 2010 Tax Credit:

1. Purchase and install qualifying products beginning January 1, 2009 through December 31, 2010. Tax credit is for cost of product only - it does not include installation costs. Tax credit is for taxpayer's principal residence only.
2. ProVia Aluminum Storm Door must be installed in an opening with an entry door and must have a glass sash in the storm door.
3. Must have this Manufacturer's Certification Statement to qualify - it is a signed statement from us certifying that the product or component listed below qualifies for 2009-2010 tax credits. Taxpayer must keep a copy of this certification statement and purchase receipts for their records, but do not have to submit a copy with their tax return.
4. Tax credit is 30% of product cost or a maximum amount of \$1,500.00 in 2009 and 2010.
5. Improvements made in 2009 will be claimed on your 2009 taxes (filed by April 15, 2010) using the IRS Tax Form 5695 (2009 version) - it will be available late 2009 or early 2010.
